6. Wai Connection

The purpose for which the Grant is provided is to enable Mountains to Sea Conservation Trust (MTSCT) to deliver its Wai Connection project. Wai Connection aims to connect people with their local waterway and promote collaboration between catchment groups, NGO's, hapū, regional council, central government, and primary industry to help deliver on the goals of Essential Freshwater package. The project will utilise and expand the existing network of catchment and regional coordinators through Mountains to Sea Conservation Trust (MTSCT) and regional provider organisations to deliver tailored packages of support to catchment groups and communities. Wai Connection will be implemented via a multi-step programme being undertaken in each region by MTSCT and regionally based provider organisations, with overarching technical and management support provided at a national level by MTSCT and EOS Ecology. This allows for consistency in approach across the country, while having the ability to respond to region and catchment-specific needs. Knowledge-sharing and engagement with iwi/hapū, NZ Landcare Trust (NZLT), regional council, and primary industry to avoid undue repetition within regions is a key element of this project. National and regional steering groups, a co-convened communities of practice framework with NZLT, and regular stakeholder meetings will reinforce strategies, provide opportunity to strengthen partnerships and networks, enable coordination and integration of efforts, and ensure policy implementation advice can be offered. The project will enhance the capacity and capability of catchment group members and partners (rural decision makers, landowners, tangata whenua, local community, councils) to increase community-led catchment management and freshwater monitoring and improvement. The social infrastructure built up will support current and future environmental policy, e.g. the transition to the Natural and Built Environments Act.
